





Member programs

Presenters Capacity Building Program

The eleventh edition of this program was delivered with Canadian Heritage (CAPF) funds by both RIDEAU and CAPACOA to presenting members in 2024-2025.

Following a rigorous two day peer assessment, the program delivered \$140,000 in capacity building funds presenting organizations under three components: organizational consultation, mentoring, and professional development.



33 applications were received for this program. 15 recipients were selected.

Projects

Indigenous Directory Development

- This collaborative project is coordinated in partnership with Ontario Presents and Talking Stick Festival.
 CAPACOA was funded by the Canada Council for the Arts to support the project.
- By creating a directory of Indigenous presenters, the project aims to strengthen and build the touring
 network of Indigenous arts. The directory will also identify non-Indigenous presenters with a historic
 commitment to presenting and programming Indigenous arts, and Indigenous presenters in communities
 across northern Turtle Island. The intent is to foster collaborations, expand knowledge of established and
 existing programming, and build meaningful relations and connections for touring Indigenous artists
 within institutions and neighboring Indigenous communities.
- The project began in 2024 and was still underway at the end of the fiscal year.

Indigenous Touring Network Development


- The ongoing project, referred to as the Indigenous Touring Network study, is a collaborative initiative between CAPACOA and Full Circle: First Nations Performance, supported by the Canada Council for the Arts. Its primary goal is to enhance the touring experience for Indigenous artists by fostering deeper, more meaningful, and culturally sensitive relationships within the performing arts community.
- The project began with the idea of creating a directory of Indigenous and non-Indigenous presenters and artists across Canada. However, the team quickly recognized that a simple directory would be insufficient, as previous attempts faced issues with maintenance and becoming outdated. The focus has shifted from merely listing contacts to cultivating relationships and building an Indigenous-led network grounded in Indigenous protocols and ways of working. Touring is reframed not as the movement of "products," but as the movement of people, culture, and stories. Ultimately, the vision is to connect with existing networks in Australia and Aotearoa (New Zealand) to form a Tri-Nations Indigenous touring network, potentially expanding to other Indigenous nations globally.
- The project is designed to be responsive and organic, constantly adapting based on conversations with various stakeholders.
- This incredible work is being led by Denise Bolduc and Nathan Mudge.

Indigenous Body of Work

- The Indigenous Body of Work is an endeavour that arose from <u>The First Cycle: Indigenous Theatre</u>, 10 years ago. IPAA undertook to build and maintain a list of Indigenous performance works to represent a "canon" of Indigenous works.
- At present, inclusion in the Indigenous Body of Work is submission-based and it is a simple text-based list sorted by author. CAPACOA has consulted with IPAA on rekindling this project with the help of CAPACOA's new Indigenous Librarian, in conjunction with the Artsdata project.
- The Indigenous Librarian has begun expanding the original IPAA list in preparation for minting these
 works in Wikidata. CAPACOA's Indigenous Librarian was given access to the Indigenous Performing Arts
 Alliance's website to retrieve submission information and add works on the backend.
- The Indigenous Librarian is close to completing the first batch of submissions to IPAA. This upload will
 add 70 new performance works to the Indigenous Body of Work, representing an increase of 16% in
 number of works.

Indigenous Performance Calendar of Events featuring Indigenous Artists

- This project has been developed as a part of Artsdata's work with the Indigenous Performing Arts
 Alliance to improve the visibility and discoverability of Indigenous artists online. It was notably meant to
 complement the Indigenous Body of Work, and to contribute to the Indigenous Directory project.
- This calendar takes a new and unique approach: it is populated by linking data from multiple open data sources. Queries are run across Wikidata and Artsdata to retrieve any event where the performer is self-identified as an Indigenous artist, group or company. Then, query results are automatically assembled into a single feed and loaded into the calendar.
- In honour of the National Day for Truth and Reconciliation, September 2024, CAPACOA released a first
 prototype of a calendar of events featuring performances by Indigenous artists. This initial version,
 populated into a Google Calendar, was published on CAPACOA's website.
- Then, CAPACOA worked in collaboration with Culture Creates, IPAA, and Jensen Group to develop a new version with an enhanced design. This version was published on IPAA's website in February 2025 and is still running today: https://ipaa.ca/indigenous-performance-calendar/.
- Today, the Indigenous Librarian is actively contributing to the calendar, using the Footlight CMS software, to ensure the data is complete and to preserve past events' data in Artsdata's core graph.
- This calendar fills in an important information gap in the performing arts sector by centralizing dispersed information into a single source of data about Indigenous performances. We hope that it will be of particular interest to presenting organizations in search of new Indigenous talent.



Classical & Heritage Arts Initiative (CHAI), Networking Support



- Volunteer network leader Nina Buddhdev, from The BANDISH Network, has been funded to lead dialogues with current and potential members of this Heritage Arts Network Community.
 - The BANDISH network's objectives are "to influence, connect, inspire, forge collective working relations, develop new dialogue and redefine ideas for the advancement of Asian heritage artists, promoters, presenters, venues, and producers interested in genre-specific engagement.
 - The network focuses on artist needs and aims to 'connect, empower and create', to develop a fuller understanding of the Indian Classical arts movement in Canada.
 - Members are from provincial, national and international influence who all play a vital role in the impact of global heritage arts.
- In an effort to encourage a greater understanding of national and provincial offerings, while encouraging
 the implementation of new artist supports and presenter practices that could be adopted to assist the
 presenting of these artforms, CAPACOA has funded network meeting opportunities, and are in the
 process of initiating a project proposal to launching a regular knowledge sharing series.
- A national meeting was scheduled for Feb 18th, to further inform the project's direction.
- The project will be designed to support the development of sustainable knowledge sharing spaces and resources, along with networking opportunities.
- Recordings from past sessions, and updates about ongoing meeting opportunities with CHAI are listed online. All are welcome to participate

Re-imagining Customer Relationships Project

(aka Loyalty and Affiliation Project)



Representatives from project partner organizations – National Arts Centre (NAC), WolfBrown, Orchestras Canada, CAPACOA and the Professional Association of Canadian Theatres (PACT) celebrate a successful professional development gathering of national delegates at the National Arts Centre, in November 2024.

In Spring 2024, the National Arts Centre (NAC), Orchestras Canada (OC), the Professional Association of Canadian Theatres (PACT), and CAPACOA launched a collaborative initiative to design, test, and evaluate strategies to deepen loyalty among regular arts goers and develop affiliation among occasional arts goers. This project seeks to support the rebuilding of Canadian audience dependability post-COVID. Structured as a multi-year, national open-access research initiative, it is further supported through a university-linked postgraduate program at HEC Montréal and builds on recent findings shared by WolfBrown.

Community Gathering:

- On November 13-14, 2024, an in-person community gathering was held at the NAC in Ottawa to explore how Canada's performing arts sector can strengthen its connection with the public.
- With facilitation support from WolfBrown, invited organizations took part in breakout groups, each focused on one of <u>five areas of experimentation</u> identified in WolfBrown's findings, to examine challenges and opportunities for advancing organizational practice.
- The event brought together 61 participants from across every province, including a significant number of representatives from rural and remote communities.
- The design of the event was highly praised, discussions were dynamic, and more than 60 pages of notes were generated providing valuable research material.



- The five areas of experimentation explored at the gathering went on to shape the project's three field studies.
- Participants expressed strong enthusiasm for the field studies, with many noting they intended to put
 ideas from the discussions into action, regardless of whether or not they were ultimately selected to take
 part (as reflected in the testimonials).



Delegates from PACT, Orchestras Canada, and CAPACOA participate in rotating group, round table discussions.

National Arts Centre, November 2024.

Virtual Webinars:

- The RCR project was officially launched to the wider performing arts community on January 28, 2025, through a virtual webinar.
- During this session, breakout group facilitators from the November 2024 gathering shared overviews of the discussions related to each of the five areas of experimentation. The NAC also presented a summary of its research conducted with WolfBrown, which served as the foundation for this project.
- The webinar drew 113 participants, and feedback was overwhelmingly positive, highlighting strong enthusiasm for the initiative.
- A follow-up webinar was held on February 5, 2025, to launch the project's first field study, *Supporting Initiators*. This session attracted 42 participants.
- The research team presented the study's methodology, and we introduced the call for applications along with the timeline for the field study.

Supporting Initiators Field Study:

- The call for applications closed on March 23, 2025, with 26 organizations from across Canada applying to participate.
- On March 31, 2025, a selection committee, composed of one representative from each project partner organization, selected the participants for the field study.

- Five organizations were selected: the City of Kingston (Grand OnStage presenting series at Kingston Grand Theatre), SPEC du Haut-Richelieu, Pacific Opera Victoria, Gateway Theatre, and the Saskatoon Symphony Orchestra.
- The field study is organized into two phases: the research phase and the experiment phase.
- During the research phase, the RCR research team will interview participating organizations to understand how cultural organizations identify and engage initiators (individuals who organize cultural outings for their friends).
- Initiators themselves will also take part in a second round of interviews to provide insight into their motivations and objectives as organizers of these outings.
- The data collected will be analyzed and used to develop a handbook of recommendations, which
 performing arts organizations can consult to enhance how they identify and engage initiators in their
 coordination and purchasing processes.
- Once the handbook is released, additional organizations will be recruited to test these recommendations through pilot experiments during the experiment phase.



The Reimaging Customers Relationship project was supported by the Government of Canada, Mitacs, through the Mitacs Accelerate program, the Azrieli Foundation (through Orchestras Canada), and the Metcalfe Foundation (through Orchestras Canada).

Research

- CAPACOA fully reviewed and updated the regular <u>Performing Arts Statistics</u> page.
 This page contains selected research snippets and continues to draw several visitors to the CAPACOA website.
- CAPACOA also continued to participate in the <u>Culture Statistics Strategy</u>
 <u>Consortium</u>. CAPACOA joined the CSSC in 2020 to support the development of
 new statistical programs as part of the Culture Satellite Account (such as the
 National Culture Indicators). Being a member of the CSSC also provides access
 to detailed Statistics Canada tables and enables CAPACOA to build bridges
 between the world of statistical data and that of linked open data.
- CAPACOA sponsored a special edition of Statistical Insights on the Arts dedicated to the <u>Performing arts: Jobs, revenues, and direct economic impact in 2023</u>.
 Thanks to the sponsorship, the full article is available for non-subscribers.

Artsdata Project

2024-2025 was the second year of the Artsdata project, which superseded the Linked Digital Future Initiative. This project is managed by CAPACOA on behalf of the Artsdata Community Group, a community of users that serves as a governing body for the project. The project was funded by the Department of Canadian Heritage (Year 2 of a 3-year Canada Cultural Investment Fund contribution) and the Canada Council for the Arts (Year 1 of a 3-year Grow Grant).

Here are some highlights from the Artsdata project for the year 2024-2025:

- Artsdata beefed up its own digital presence with a new <u>Artsdata corporate site</u>, an enhanced <u>knowledge</u> <u>graph interface</u>, and significantly expanded documentation pages.
- Following recommendations in the <u>Enhancing and connecting performing arts systems report</u>, we helped <u>Scènes francophones</u>, <u>I Want to Showcase</u> and <u>Arts Touring Connector</u> implement open data policies and share their data with Artsdata.
- We led consultations with artists, agents and artistic companies to understand their information management needs. These consultations did not find a clear need for a dedicated app, but they nonetheless guided the development of new tools and features for Artsdata.
- We integrated 30 new data sources into the knowledge graph, including 5 membership directories and 2 ticketing platforms. These sources bring the total number of data feeds above 140 (see all sources).
 15,000 events were uploaded to Artsdata during the year
- Several new features were implemented to make it easier for Artsdata staff to reconcile entities, synchronize data with Wikidata, and mint Artsdata IDs, thereby ensuring the metadata is preserved even when entities are deleted at the source.
- The Artsdata Community Group welcomed two new members, growing from 9 to 11. It also adopted a
 new set of governance principles and defined a dual-governance model along with the CAPACOA board of
 directors.
- Artsdata's community building, data literacy activities and other programs and services reached 338 unique participants (566 total participants).
- Cataloguing activities focused on Indigenous arts continued with Wikidata modelling activities and the co-creation of an Indigenous performances calendar (more details above).
- Artsdata resumed the Digital Discoverability Program (more details below).

Thanks to the Artsdata team partnering with Spektrix, we can rest easy knowing our site will be more discoverable and our audience members will be sent to our site as opposed to a ticket reseller. Digital Discoverability Program

CAPACOA finished its 4th annual edition of the <u>Digital Discoverability Program</u>. This year, we received 36 unique applications and accepted 28 presenters, artistic companies, performing groups, agencies and other arts organizations to the program. Of these 28 participants, 24 were either existing CAPACOA members or joined CAPACOA during the course of the program.

Meeting one-on-one with program coordinators Dessa Hayes, Émilie Frenette and Morgan Pannunzio, participants learned how to boost the findability and shareability of their event pages and artist/member pages through structured data and other Entity SEO techniques.

Policy Development and Advocacy

Federal Government Advocacy

The 2024-2025 fiscal year began with a major win in the 2024 federal budget. Further to the #FutureOfLIVE advocacy campaign, the budget extended and increased supplemental funding for the CAPF! The program received supplemental funds of \$31 million over two years, compared to \$16 million over two years in the previous extension. The #FutureOfLIVE budget response was published within 90 minutes of the tabling of the budget.



Through the summer and fall, CAPACOA collaborated with the Canadian Arts Arts Coalition to promote the <u>LVote Arts</u> campaign during the federal election. CAPACOA supplemented the campaign with its own infographic and by monitoring and reporting on each party's platform.

Visitor Visa Guidelines & Assistance Service



- Context: Previously, CAPACOA met with representatives of Immigration Refugees and Citizenship Canada
 (IRCC) to discuss our solution pathways to streamline visa processing for visiting artists. One of the biggest
 points of contention was the eligibility criteria that international events must have a minimum of 10
 delegates from visa-required countries to be registered with the Special Events Unit. This challenge was
 overcome. It was agreed that CAPACOA would provide an alternative window for accessing Special Events
 services, when events do not meet this eligibility criteria.
- CAPACOA and the IRCC then collaborated to develop visitor visa <u>guidelines</u> and an assistance service for Canadian presenters and foreign artists, which officially launched August 26, 2024. (<u>read the</u> <u>announcement here</u>).
- Subsequent information sessions were held on October 15 and 16, with more than half of attendees representing non-member organizations.
- CAPACOA was publicly commended by a representative of the Canada Council for the Arts, during a separate information session, for taking action about this policy issue. The announcement of the program was also met with enthusiasm across the national performing arts community.
- Since its launch, both members and non-members have shared positive feedback on the clarity and structure of the guidelines, noting that it is particularly helpful when navigating the visa application process.
- Those who meet all the eligibility criteria have advised that this assistance service has also provided highly successful results.

Copyright and Neighbouring Rights

• In May 2024, it was brought to CAPACOA's attention that Entandem was denying CAPACOA members the right to report dance recitals and competitions under Re:Sound 5.K/A, a tariff that was designed for this purpose. Instead Entandem has been charging Re:Sound 5.B (Receptions), the most expensive of all Re:Sound tariffs. CAPACOA sought and obtained quick reparation from Entandem. By the end of the summer, all members who had been charged the wrong tariff had been credited the difference in their Entandem account.

Communications

All Access / Libre Accès (Newsletter)

- 12 issues were sent between April 2024 March 2025
- 7 additional Special Bulletins were sent between April 2024 March 2025
- 2,616 subscribers as of March 2025, an increase from 2,591 from March 2024
- Average readership (open rates) was 45.7%, an increase from 44.9% 2023-24 and from 35.6% 2022-23
- Average click rate was 7.4%, an **increase** from 5.8% in 2023-24

Website

In 2024–25, there were 72,100 page views, a 9.9% decrease from the 80,039 views recorded in 2023–24. While this represents a modest decline, the overall volume of traffic and engagement remains significant.

We published 23 news articles in 2024-25 (compared to 26 in 2023-24). These included:

- Calls for nominations/expressions of interest
- Advocacy-related organizational statements
- Artsdata reports and updates
- Announcement of new programs, tools, and professional development opportunities
- Snapshot Sessions 2.0 news items

More specifically, our news articles titled *Call for Expressions of Interest: Canada/Arctic Online Cohort Program & 2025 Arctic Arts Festival* and *Call for Applications – Snapshot Sessions 2.0: Projects Ready for Touring* were the most viewed with 165 and 113 clicks respectively.

Overall, our most visited pages were the job board (2,909 clicks), member directory (2,289 clicks), performing arts statistics page (1,332 clicks), and visitor visa guidelines page (1,067 clicks).

Overall participation indicators

CAPACOA's team members diligently compiled standardized participation statistics for each event and program led by CAPACOA or with which CAPACOA collaborated. Here are the key indicators pulled from these disaggregated participation statistics.

Interpretation:

- The count of unique participants 292 is an expression of the breadth of CAPACOA's engagement (everyone is counted once, no matter how often they participated).
- The count of total participants 403 is an expression of the depth of CAPACOA's engagement (how regularly people engage with our events and programs, including repeat attendance from the same persons).
- The last indicator 894 is an expression of CAPACOA's total reach across CAPACOA-led events and programs, Artsdata events and programs, jointly-led events and programs, and sessions presented by CAPACOA at events produced by others. This includes, as examples, digital literacy sessions delivered by CAPACOA at the Arts Reach conference and at Contact East.
- CAPACOA staff members are excluded from these counts (even though they are occasionally active participants or learners in some activities led by peer staff members).

Insight:


Even though 2024-2025 wasn't a conference year, the count of total participants across core CAPACOA or Artsdata events and programs – 608 – is not too far off from the previous year – 779. This 22% difference is an indication that, during off-conference years, CAPACOA manages to deliver in place of the annual conference an array of online events and special projects that engage a large cross-section of the live performance sector.

2 - Operations

Membership

During the 2024-25 year, membership grew back from 183 members to 188 members (which is almost the same as the association's highest membership count, 189, during the peak of the pandemic). The highest growths were experienced among presenter members and individual members. Economic circumstances remain difficult for all members, notably among agents and managers. Some could no longer afford to renew under their usual business member level and have opted for an individual membership instead.


LIVE Performing Arts Directory

Membership renewals were once again managed through the online <u>membership form</u> and in conjunction with the <u>open data strategy</u>.

Even though the use of the membership form provides members many benefits associated with the open data strategy – not the least of which is the display of their information in CAPACOA'S LIVE Performing Arts Directory – some members still prefer to renew using traditional methods: they await to be emailed an invoice, which they can pay with one of our easy payment options.

Throughout the year, we continued to upload member information in Wikidata, as an online digital discoverability membership benefit. We manually created Wikidata items describing our members' venues, while also creating profiles for member organizations and artists.

Theatre SKAM joined CAPACOA in January 2025. As an immediate benefit of their membership, the CAPACOA team created Wikidata items describing their venue, <u>as can be seen in their profile</u>.

They included the breadth of Professional Development opportunities made available to our membership, the progress of the Linked Digital Future initiative, the efforts of the Membership, International Market Development Initiative, Finance, and newly reconstituted HR committees, and the delivery of a new Strategic Plan by the Board of Directors.

The deliverables emphasize inclusivity, strategic planning, transparency, and the well-being of both staff and members.

Once the deliverables were defined, the committee began meeting monthly to plan the conference. Their focus was on creating an event that would showcase outstanding national talent from Canada alongside top-tier artistry from our partner nations. Given the current geopolitical climate, the committee and staff aimed to address the larger challenges facing Canada's cultural sector, while also broadening the scope to include pertinent issues affecting our closest ally nations. CAPACOA ended the 2024/2025 fiscal year with a small surplus. This is thanks to the hard work of the entire staff team to find ways of fulfilling our mission while working within the limited resources of an arts service organization.

I want to thank the members of the FORC (as our board chair Natalie likes to call it) for their continued contributions to providing oversight and asking insightful questions to ensure our financial processes are being followed. This can be challenging as so much of the work of the organization is dependent on precarious funding sources and significant adjustments are being done to CAPACOA's programs throughout the year to work within funding timelines and shifts.

On the organizational resilience side of our committee's mandate we have identified the challenges of our current operating reality with the current balance of project based staff and long-term organizational positions. We look forward to continuing to contribute to making our staffing model as effective as possible as we begin to coordinate with our Human Resources Committee and including better ways of ensuring the work we do has the appropriate level of staff time, expertise, and support to be sustainable.

The past fiscal year has been another active one for CAPACOA's International Market Development Committee (IMDC).

Highlights include:

- Participation in the Canada Council supported delegation to MASA in Abidjan, Ivory Coast;
- Coordination of a Canada Council supported delegation to PAMS in Seoul, South Korea and HK PAX in Hong Kong;
- Coordination of a year-long Presenter/Artist cohort program with colleagues from South Korea
- CAPACOA assisted in the coordination of a booth for Canadian artists and agents during the 2025 APAP market in New York.
- Delegations to Circulart (Medellin, Colombia) GREC Festival (Barcelona, Spain) followed by delegate meetings in Madrid; Edinburgh Fringe Festival (Scotland, UK); Tanzmesse NRW (Dusseldorf, Germany), YPAM (Yokohama, Japan)

The delegation activity saw 20 presenters and 14 artists visit five countries over the course of the different cultural delegations. You will find more details about each project in the Annual Report.

The IMDC's International Engagement Strategy 2021-24 expired during this fiscal year, and efforts began in August of 2023 to develop the new strategy document, including research consolidation, data gathering at the provincial and federal levels, input from CAPACOA membership and other stakeholders. The new International Engagement Strategy covering 2025 – 2029 was completed in the summer of 2024 and can be found <a href="https://example.com/here.co

In July members of the IMDC committee contributed to a written Submission for the Pre-Budget Consultations in Advance of the Fall 2025 Federal Budget. The summary recommendation of the report was that the Government of Canada provide stable funding for export assistance and growth to the Creative Industries by making permanent the Creative Export Strategy under the Department of Canadian Heritage and maintaining its current investment of 19 million dollars.

Thank you to CAPACOA staff for their contributions in putting the report forward. David Warburton, Artistic Executive Director, Port Theatre, Nanaimo, BC



David Warburton (김모세) is the Artistic Executive Director of the Port Theatre, and the President of the Canadian Dance Assembly, a national arts service organization that provides a strong voice for Canadian dance and the development of resources for the dance sector.

He is the former Company Managing Director of the Royal Winnipeg Ballet (RWB) joining the organisation in 2013 first as Company Manager and before stepping into the role as the Director of Touring and Business Development and then Managing Director. He served an integral role in reshaping and rebuilding the ballet company.

Warburton co-created the national award-winning play SANGJA, that premiered in Seoul and toured multiple times throughout Korea and Canada. He has been invited to guest speak about his work in advocacy in Vancouver, Toronto, Montreal, and Seoul. He was selected as one of nine emerging leaders for Dance/USA's Institute for Leadership Training, a program supported by the Andrew W. Mellon Foundation, that focuses on shifting patterns of inequity in

dance. He was an organizing member of the Korean Society of Manitoba from 2016 to 2022. His work in government advocacy and cultural diplomacy has meaningfully contributed to federal support for the arts and cultural sector during the COVID-19 pandemic. This has included crucial direct consultations with Deputy Prime Minister Chrystia Freeland and the Prime Minister's Office.
